- (4) The Target Date Funds replaced the Asset Allocation Funds as of market close March 21, 2014, and have a limited return history. See the Fund Fact Sheet for more information.
- (5) No transaction fees are charged. Instead, the funds indirectly incur management fees that are charged by the underlying investment funds in which the funds invest. The estimated expense ratio consists of operating expenses, including management fees and nominal trustee services fees, and an administrative expense of five basis points expense reimbursement, except the for the STIF-Cash, which is 2.15 basis points (0.0215%). Fees are netted out of the performance of the funds.
