End Notes

- (1) This fund is a separately managed portfolio of assets managed specifically for Savings Plus. It is not a mutual fund. See the Fund Fact Sheet for more information.
- (2) This fund is a passively managed commingled fund (collective trust). It is not a mutual fund. See the Fund Fact Sheet for more information.
- (3) Redemption fees may apply to these funds. See the Transfer Restrictions and Redemption Fees document on savingsplusnow.com. Refer to the Fund Fact Sheet for more information.
- (4) No transaction fees are charged. Instead, funds indirectly incur management fees that are charged by the underlying investment managers. The estimated net expense ratio consists of operating expenses, including management fees and nominal trustee services fees, and an administrative expense reimbursement. These fees are netted out of the performance of the funds.
- (5) The Net Expense Ratio for this fund includes an expense reimbursement of five basis points (0.05%), which is paid to Savings Plus to administer the program.
- (6) A shareholder reimbursement of approximately 2.85 basis points (0.0285%) is paid to Savings Plus from the Government Money Market fund managers. Additionally, the Net Expense Ratio for this fund includes an expense reimbursement of 2.15 basis points (0.0215%), which is paid to Savings Plus to administer the program. These two amounts total five basis points (0.05%), which is equitable to the expense reimbursement of the other Savings Plus investment options.
- (7) The fee-adjusted return presented in the Investment Performance Report is an estimate.
